

#### Introduction

Any installation on the campsite requires the permission of the campsite manager. Staying on the campsite implies acceptance of the provisions of these rules and the commitment to comply with them. Any infringement of these rules may result in the immediate expulsion of the person responsible. Any person staying at least one night on the campsite must be able to present an identity document and a certificate of civil liability insurance covering the members of the family against damage caused to others at the reception desk and complete the required formalities.

# Health measures (Covid-19)

They will be specified in accordance with the government guidelines in force at the time of opening.

# Identification of campers

A green bracelet will be given to all campers staying on the campsite against a deposit of  $5 \in$  to allow the management team to identify them easily and to limit access to intruders, particularly in the sanitary blocks. In addition, **this bracelet allows the activation of the showers in our sanitary blocks**.

#### Admission of minors

In the absence of a parent or legal guardian, minors must be accompanied by an adult over 20 years of age during their stay and must provide a parental authorisation upon registration. They must present their identity card, as well as a photocopy of the identity card of the person signing the authorisation.

#### Admission of animals

They are welcome on the basis of one animal per family unless prior authorisation is given by the management. All owners must be able to show the animal's up-to-date vaccination record on arrival. Animals must be kept on a leash and never be left alone, even locked up in the accommodation in the absence of their master, who is civilly responsible for them. No noisy animals will be allowed on the campsite. 1st and 2nd category dogs are strictly forbidden on the campsite.



# **Private pitches**

The camper may only occupy the plot allocated to him and according to the options he has chosen. Only one "hard standing" accommodation is allowed per pitch: 1 caravan or 1 motor home and an awning. A small extra tent for 2 people may be accepted after approval by the management. Campers in tents may set up 1 large or several small tents, up to a limit of 6 people, on the same pitch. Only 1 vehicle is allowed on the private bare pitches. The others must be parked outside the campsite. Exceptionally, and on prior request, the car may be replaced by a small additional accommodation.

# Shared space "green beach

This area is reserved for short-term guests. Only tents for up to 2 people are allowed in this area. Vehicles must remain in the car park.

# **Hiker's Tents and Cottages**

Except during installation and departure or in special cases to be notified in advance, vehicles must remain in the car park in order to preserve space and comfort for guests. Sheets or sleeping bags and pillowcases are compulsory. Disposable sheet kits are on sale at the reception. The accommodation must be left in the same condition as it was found on arrival. Rubbish bins must be put in the rubbish bin in the car park.

The use of **the washing machine and tumble dryer** can be booked at the reception (fee payable)

#### **Payment of services**

The tourist tax is set at 0.22cts per night and per adult over 18 years old. The payment of the stay can be done directly online on the campsite website or at the reception, by cheque, cash, credit card or bank transfer. ANCV cheques are accepted for stays of 3 nights minimum and for a maximum of 50% of the total amount of the stay. A deposit of 30% is required at the time of booking and the balance at the latest 48 hours before the departure date. On prior request, an arrangement of the payment is possible in agreement with the management.



#### **Arrivals and departures**

#### For private pitches:

Arrivals are from 15:00 (unless previously informed by the manager) and **departures before** 12:00. Departure must be confirmed at the reception desk the day before in order to check the state of the site.

# For rentals (tents and cottages):

**Arrivals are from 15.00** (unless previously informed by the manager) and **departures before 10.30.** Departure must be confirmed at the reception desk the day before in order to check the state of the premises.

# Day/night of absence (dead garage)

In case of temporary absence, the full fee for the pitch is due. The campsite is not responsible for material left behind in the absence of the owners.

#### Visitors to the site

Visitors must report their presence to the reception desk. They are admitted to the campsite for the day under the responsibility of the campers who receive them. Visitors who wish to stay one or more nights on the campsite must register at the reception desk and pay the resident's fee. Visitors' vehicles are not allowed on the campsite.

#### Noise and attitude on the campsite

The campsite will not be open to anyone who is intoxicated, or to any events that could disturb the stay of the customers. The users of the campsite are requested to avoid any noise and discussions that could disturb their neighbours. Sound equipment must be adjusted accordingly. From 10.30 p.m. to 7.00 a.m., it is expressly requested to respect the rest of everyone; the closing of doors and trunks of vehicles must be as discreet as possible. Correct and decent dress is required on the campsite for the respect of all.



# Vehicle traffic and parking

Within the campsite, traffic is limited to 10 km/h. Only authorised vehicles belonging to campers staying at the campsite may circulate within the campsite. The entrance to the campsite is open until 10 p.m., after which time vehicles must remain in the outside car park. No traffic is allowed between 10.00 pm and 7.30 am. No vehicles may be parked anywhere other than the campsite pitch reserved by the camper.

#### **Electrical connection**

The campsite does not provide electrical equipment. It is strictly forbidden to tamper with the electrical terminals and the safety system of the sockets. The campers' electrical connection material (cables, CEE adapters) must be compatible with a standard connection power supply with 10 ampere terminals. Cables must be of a single length between the distribution point and the place of use. Multiple sockets are not permitted.

#### **Respect for the environment**

Everyone is obliged to refrain from any action that could harm the cleanliness, hygiene and appearance of the campsite. It is forbidden to throw polluted water on the ground or into the gutters. Household waste, waste of any kind and paper except bulky items must be deposited in the rubbish bin in the campsite car park.

It is IMPERATIVE to respect the selective sorting required by the commune: yellow container for recyclable products, grey container for common food waste, glass in the dedicated container outside the establishment.

#### **Camping car drivers**

The campsite has a grey water drain opposite the reception. The cassettes can only be emptied into the lower toilet, which must be cleaned after each use. A water hose is available for this purpose. Their use is exclusively reserved for campsite guests after the handover of the keys.

**Washing of dishes and laundry** is strictly forbidden outside of the containers provided for this purpose. The hanging of laundry is tolerated on the pitch, provided that it is discreet and does not disturb the neighbours.

Any damage to the vegetation, fences, ground or facilities of the campsite will be charged to the person responsible. It is also forbidden to dig up the ground.



The pitch that has been used during the stay must be cleaned on departure and returned to its original state.

# Fire risk

Open fires on the ground (wood, coal...) are strictly forbidden. A fixed barbecue is available to campers near the laundry room. Individual barbecues are allowed in compliance with safety rules (outside and at a respectable distance from tents and caravans and from vegetation). Gas stoves and barbecues must be in good working order. In case of doubt, the campsite manager may forbid their use. Fire extinguishers are available to everyone in the boxes provided for this purpose. In the event of a fire, immediately notify the campsite management and dial 18. A first aid kit is available at the reception.

#### Theft and other damages

The management declines all responsibility for theft, loss or damage of any kind during or following a stay on the campsite. The camper is responsible for his installation and it is his responsibility to take out civil liability insurance. Children remain under the responsibility of their parents or adults responsible for them inside the campsite, and during all activities or games on the campsite. No violent or disturbing games may be played in the vicinity of the facilities. Please report any suspicious persons on the campsite immediately to the person in charge.

#### **Reception office**

The opening hours of the reception office vary according to the season. Please consult the office. In high season (July and August) the opening hours are from 8.30am to 12.30pm and from 3pm to 7.30pm. In case of absence, outside these hours and in case of emergency only, a telephone service is available: **06 11 82 13 02**
